SAFETY IS KEY FOR YOUTH

Today I attended the National Steering Committee meeting for SAY, Safety in Agriculture for Youth, a program funded by USDA -NIFA (National Institute of Food & Agriculture). I was appointed to this committee representing National Grange last year and participated in several conference calls, but this was the first face-to-face meeting.

The Grange has a rich history of supporting agriculture as a family business and on-farm training of our children and youth as "apprentices". Tragically, many children and youth are killed or disabled each year in farm safety incidents that could be prevented. SAY is an educational program to increase awareness of unsafe conditions and to provide resources to teachers, 4-H leaders, and other trainers who can teach youth the importance of constant safety

awareness.

What are the first lessons parents teach a child? Safety. How many times did you say to your toddlers "NO—that's hot," or "Don't do that, you'll fall!"? Our first lessons in safety come from our parents. But as our children grow and mature, most families do not have farm or home businesses so children are not taught mechanical skills or how to operate machinery. Even lawn-mowing, a standard task for teenagers, may not be possible, as many families live in apartments or condos or hire a lawn service. It was mentioned at the meeting that few young men or women qualify for the Marines because they are not physically fit enough to get through basic training without injury.

If youth have not had any work experience before their first "real" job, they have not developed the culture of safety that comes from working alongside a parent through their formative years. Part of the mission of SAY is to develop this culture of safety in high school, in FFA, 4-H, agriculture classes etc. As citizens concerned about agriculture, we need to police ourselves, to stress safety and reduce the number of farm accidents, or we will face more government regulations or even lose our ag exemptions for farm labor.

The best way to impress safety on our youth is through other youth. I challenge our Grange youth to be aware of their work surroundings, suggest safety improvements, and talk to their peers about staying safe. Our future food and fiber production depends on it.

There are many resources available to help you teach safety. Check out the Clearinghouse at www. extension.org/SAY or the YouTube channel AgSafety4u. The National Grange has endorsed the SAY Belief Statements

- Creating and promoting a culture of safety among youth working in agriculture is a primary goal for all stakeholders.
- All youth working in agriculture deserve protection from workplace hazards and risks that may be associated with agricultural worksites.
- Youth developmental principles are the basis for determining if and when a youth should participate in agricultural work.
- Supervision of youth performing jobs or tasks should be guided by professionally recognized best practices based on developmental stages of growth.
- Research and evaluation should guide development of safety and health best practice recommendations and guidelines.
- Evidence-based, culturally appropriate models should be utilized to educate about agricultural safety and health.
- Hired youth working on farms subject to Occupational Safety and Health Act (OSHA) enforcement should be informed of applicable rights to a safe workplace, training, personal protective equipment, and to ask questions or raise concerns about their safety.

VOTERS FAVORABLE TO AGRICULTURE

Sustainability.

It's a word that means widely different things to different people. Sustainable agriculture is defined by the 1977 and 1990 farm bills as a system that will satisfy human food and fiber needs, enhance environmental quality, use resources efficiently, sustain the economic viability of farmers, and benefit society as a whole. How confident is the public about agriculture's commitment to sustainability?

The Morning Consult (public policy newsletter) recently asked 1,917 registered voters to give their opinions regarding agriculture and sustainability based on the farm bill definition. Mostly, Americans think agriculture and farming are among the nation's most sustainable sectors. Here are some interesting responses from those polled:

- Agriculture is sustainable. Among Republicans 80 percent say yes and 76 percent of Democrats agree that agriculture is sustainable
- Incentives are best. Cooperative incentives that allow government and farmers to work together to address issues is preferred over farm regulation
- Respondents said they trust farmers to make the right decisions about sustainability
- Respondent's favorability ratings for several major U.S. business sectors were, agriculture 78 percent, technology 76 percent, hospitality industry 73 percent, manufacturing 67 percent, energy 60 percent, airlines 54 percent and pharmaceuticals 43 percent.
- A huge majority of respondents agreed with the statement that "the true success of environmentally sustainable farming depends on whether that practice also leads to economic opportunity for the farmer."

NATIONAL PRESIDENT APPOINTED TO FCC COMMITTEE

The National Grange is pleased to announce that National President Betsy Huber has been appointed a member of the Broadband Deployment Advisory Committee. FCC Chairman Ajit Varadaraj Pai made the announcement Thursday, April 6, 2017.

The Committee "will provide advice and recommendations for the Commission on how to accelerate the deployment of high-speed Internet access," according to the Federal Communications Commission. The first meeting will take place this month at the FCC headquarters.

We are excited to be involved in the FCC's efforts to bring broadband access to rural areas on this level.

One of the resolutions sent to the 150th Session of the National Grange this past November asked that Granges honor Police Officers in their communities.

During the committee discussions it was decided to include the concept in their policy statement as the committee recognized that the National Grange Community Service Department already has a national contest to honor a Teacher, Firefighter/EMT and Law Enforcement Officer of the Year. The committee and the delegate body as a whole believe that each Grange should honor those who serve their local communities.

Those who serve our communities in law enforcement and the fire service, whether volunteer or paid, have been under greater pressure and scrutiny recently with all that is going on in our country. The delegates to the National Grange felt that as a community based organization, the Grange at all levels needs to step up and honor/recognize those who serve and help us in our local communities. This is another way to open our halls to our communities and to say thank you, "job well done" to those who make a difference every day as well as showing our communities that Grangers realize and appreciate the importance of those who serve our communities.

We have had conversations over the past three months about putting together a collaborative program addressing this idea. We both believe that the idea of Grange committees working together on programs is one excellent way to strengthen a Grange and we are excited to announce the Blue Line and Red Line Honor Program. The Blue Line and Red Line Honor Program is one way the Lecturer and the Community Service chairperson can work together to recognize community members that serve in law enforcement and the fire service. The successful collaboration between Lecturers and Community Service chairpersons is paramount to an active, relevant and healthy local Grange.

To support the Blue Line and Red Line Honor Program the National Grange will provide certificates upon request to Granges who will be honoring those in either law enforcement and/or the fire service.

The Blue Line and Red Line Honor Program is not meant to supersede the current "of the Year" program used by Granges in many states and communities, but to enhance this program by getting more local law enforcement and fire service members recognized and thanked for their service.

We encourage each State Grange to have an "of the Year" program - you don't have to honor all of the categories each year, NJ does one category a year which works well for them. We both believe this is a way of increasing participation throughout

the Grange as well as increasing recognition of our Granges.

Some ideas we would like to share with you for program/community service ideas are:

Lecturer: Kuna Grange (ID) has a program where they honor their "of the Year" recipients at an open house meeting where they invite the community to attend. Last year they recognized Firefighter, Teacher and Law Enforcement of the Year winners. They invite the local newspaper and make it a very special evening and have a special cake made. This is just one example of many Lecturer programs of this type we have seen throughout the nation.

Community Service: Elmer Grange (NJ) for several years when they have a dinner at the Grange Hall

they make up some to go containers for the local NJSP barracks. The Grangers then call the barracks and one of the Troopers then picks up the meals. They always appreciate this as it gives them a home cooked meal during their shift. This idea could be expanded to taking meals to the local fire station for the firefighters on a drill night. If there is a local hospital in the area a Grange could take some home cooked meals to the nurses and Doctors working in the ER.

These are just a couple of ideas and we are sure there are Granges out there doing similar things and we would like to hear from you what they are so we can share them with the State Directors of our two departments. We are excited about the idea of our Departments on the National Grange level working on other collaborative projects. We also look forward to working with the other National Grange Departments in the future.

For 150 years, the Grange has been an organization filled with patriots who wish to share their talents with individuals in their community and world. Last year we encouraged Granges and Grange members to identify veterans or active duty service members of their Grange or community who were deployed during war time and request for them a Quilt of Valor (QoV).

We encourage you to continue to seek out those who are eligible to receive a QoV (as outlined at www. qovf.org), and to contact me if you know of a member who has received or will receive a QoV. Email lecturer@nationalgrange.org or call (509) 953-3533 and provide the name of the veteran/service member, your Grange's name and any other details you may have.

During our Great American Quilt and Handicraft Expo in November, we will have a first-of-its-kind memorial in which we will display QoVs awarded to Grange veterans and service members and we hope we can further honor your members by having their Quilt of Valor displayed at the event.

Please don't forget, certificates are available for FREE from the National Grange to recognize veterans of World War II, Korea and Vietnam and the conflicts not classified as wars during the Cold War Era. Certificates will be available in mid-2017 for Gulf War Veterans and in early 2018 for all those serving in the post-9/11 era conflicts/wars. This program is sponsored



by Potomac Grange No. 1 (DC). Informational DVDs are available to explain WWII - what led to the war, the war itself, its toll and its impact on our nation - and the Korean War. DVDs on Vietnam and the Cold War conflicts are expected out in 2017 and Gulf War and Post-9/11 in 2018. These can be used to glean information needed for a great lecturer's program or can be an introduction for Junior Grangers and Grange Youth to citizenship and patriotism lessons.
