Installation reminds us of our pledge

In my Grange, September is traditionally the month for the election of new officers and their installation. I know some Community Granges are on a different schedule, but many elect and install in the fall.

I urge you to perform the Installation Ceremony in the Subordinate Manual, either the full form or the alternative form. These words are extremely valuable in instructing the officers of the duties they are assuming. The alternative version is succinct and to the point, in modern language taking only 20-30 minutes to do. The full form is more historical, flowery language and takes longer but, like great literature, is beautiful to hear and reminds us of our legacy.

If you don't have an Installing Officer willing to come to your Grange, try having each officer read aloud their charge in turn. Or have each officer install the next one in line - an executive committee member installs the President; the President installs the Vice President; the Vice President installs the Lecturer, and so on.

The important part of the ceremony is the pledge to perform the duties of the office and abide by the Constitution and By-Laws of the Grange. These pledges mean something within our Grange and even in courts of law. When a person becomes a Grange member and takes the obligation in the Degrees or the Welcoming Ceremony, when a new Grange is formed and members sign the charter application, and when officers pledge to perform their duties - these pledges are just as binding as signing any contract and have been used in recent court cases upholding the Grange rules.

No matter how you choose to install your officers, it is vital that you DO install them using the pledge and instructing them in their duties. And then mentor them as they take on new, unfamiliar tasks. Your Grange will be better for it!

The impact of “Thank You”

It shows we are paying attention to the little things and deeply appreciate what our members accomplish. We need to remember we are not the only ones who have busy schedules. The members of this organization are the true backbone of the Grange, so we need to thank and encourage our members whenever we can. It could be done at the event or during a meeting so they are publicly thanked. It is something so simple but so overlooked at times.

Throughout the Convention, they will be presenting their projects and talking to attendees about the

benefits of the program.

You can also expect to hear from some amazing guest speakers on topics such as mental health awareness and substance abuse. Attendees will also have the opportunity to receive certification in dispensing Narcan, a life-saving medication that can treat a narcotic overdose in an emergency situation.

On Tuesday, the Centers for Medicare & Medicaid Services (CMS) released a Request For Information (RFI), seeking public input on accessing healthcare and related challenges, understanding provider experiences, advancing health equity, and assessing the impact of waivers and flexibilities provided in response to the COVID-19 Public Health Emergency.

The *Make Your Voice Heard: Promoting Efficiency and Equity Within CMS Programs* RFI furthers CMS’ commitment to engaging and learning from partners, communities, and individuals across the health system to inform how we can better support the populations we serve. In alignment with [Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government](#), the [CMS Strategic Plan Pillar: Health Equity](#) and the [CMS Framework for Health Equity \(2022-2032\)](#), this RFI aims to gather feedback and perspectives related to challenges and opportunities for the Agency to embed health equity into our efforts encouraging innovation, reducing burden, and creating efficiencies across the healthcare system.

CMS is seeking to better understand individual and community-level burdens, health-related social needs, and opportunities for improvement that can reduce disparities and promote efficiency and innovation across our programs. CMS is requesting information related to strategies that successfully address drivers of health inequities, including opportunities to address social determinants of health and challenges underserved communities face in accessing comprehensive, quality care. For example, challenges accessing care may include understanding coverage options, receiving culturally and linguistically appropriate care, accessing oral health services, and accessing comprehensive and timely healthcare services and medication.

CMS encourages comments from all interested stakeholders, in particular, patients and their families, providers, clinicians, consumer advocates, and healthcare professional associations. We also encourage comments from individuals serving and located in underserved communities, and from all CMS stakeholders serving populations facing disparities in health and healthcare. The RFI is open for a 60-day public comment period beginning

September 6, 2022. Comments must be received by November 4, 2022 to be considered.

The web-based public comment form was specifically designed to provide easy access and an improved user experience for submitting information.
