## A little mentoring goes a long way

[Last week](#), I wrote here about the importance of the Installation of Officers ceremony each time you elect officers in your Grange.

This week, I'll take that one step further and talk about assigning mentors to the members who are taking on new offices. We've all been in that place - it's so easy to sit on the sidelines and critique the job that others are doing, but when you are suddenly asked to substitute for the Assistant Steward in the Opening of the Grange, it's a whole 'nother point of view. "Simple" tasks like opening the Bible or presenting the Flag are a lot more difficult when you're out there on the floor trying to remember if you should walk single file or three abreast! Rather than throwing the new officer into the deep end, provide some instruction to them to save any possible embarrassment.

Perhaps during the first meeting after an election, prior to the Installation of Officers, run through the ritual of the meeting as a practice to make sure everyone knows their part and all those unwritten customs that we have in our local Granges. The outgoing officer can give their successor some simple instructions and tips on how to perform the new duties.

Even long-time members who are elected to a new office will appreciate a review of proper procedures to make the meeting flow smoother and more efficiently. This applies to floor work and to other responsibilities of the various offices. A little mentoring and instruction go a long way to making your members feel comfortable and your meetings pleasant experiences

## Updated COVID-19 Vaccines Providing Protection Against Omicron Variant Available at No Cost

This week, the Department of Health & Human Services (HHS), through the Centers for Medicare & Medicaid Services (CMS) announced that people with Medicare, Medicaid, Children's Health Insurance Program (CHIP) coverage, private insurance coverage, or no health coverage can get COVID-19 vaccines, including the updated Moderna and Pfizer-BioNTech COVID-19 vaccines, at no cost, for as long as the federal government continues purchasing and distributing these COVID-19 vaccines.

The U.S. Food and Drug Administration (FDA) has authorized the Moderna and Pfizer-BioNTech updated vaccines that target the original COVID-19 viral strain and two Omicron variants (BA.4/BA.5) that are currently the most prevalent in the U.S. Individuals are eligible for their updated vaccine shot at least two months after completing at least their primary vaccination series (two doses of Pfizer-BioNTech, Moderna, or Novavax, or one dose of Johnson & Johnson)—regardless of how many monovalent COVID-19 boosters they have received to date.

The updated Moderna vaccine is authorized in individuals 18 years of age and older while the updated Pfizer-BioNTech vaccine is authorized for individuals 12 years of age and older.

The Centers for Disease Control and Prevention (CDC) recently updated its [recommendations](#) regarding updated COVID-19 vaccines.

COVID-19 vaccines are the best defense against severe illness, hospitalization and death from the virus. CMS continues to explore ways to ensure maximum access to COVID-19 vaccinations. ## **Advocacy Playbook: Permitting Reform Bill**

### **Background:**

In the 1960s and 70s, Congress created and passed a series of bills intended to protect and preserve the natural environment for future generations, most prominently the National Environmental Policy Act, the Clean Air Act, and the Clean Water Act. Collectively, these pieces of legislation have created the process by which large and small infrastructure projects alike are reviewed, processed, and finally approved or rejected for construction. As long as this regulatory approval regime has existed, it has had its critics who say it errs too far in favor of environmental protection over necessary infrastructure construction or, even worse, serves as a forum for frivolous complaints intended to stop disliked projects regardless of actual environmental concerns. In recent years, these critics have been increasingly joined by climate change activists who have realized that the environmental review process has frequently slowed down or stopped the construction of the renewable energy and electricity transmission projects which are needed to decrease carbon emissions. With a broader coalition of critics, recently a bipartisan Congressional effort to reform the infrastructure permitting process has begun.

### **Legislation:**

While legislative text of the forthcoming permitting reform bill has not yet been released, leading Senators have outlined potential provisions. Senator Joe Manchin (D-WV) has led the effort to pass a permitting reform bill and has indicated his support for provisions that would require maximum environmental review timelines for select infrastructure projects, streamline permit requirements with regard to agency jurisdiction and filing, set statute of limitations and other restrictions on legal challenges to potential projects, and enhance federal permitting authority for electric transmission facilities. Senator Manchin has placed a particular emphasis on the approval of the Mountain Valley Pipeline, a gas pipeline key to his home state of West Virginia. While many Democrats in Congress have indicated their support for permitting reform, some have expressed concerns about weakening environmental protections and not wanting to speed permitting for oil and gas projects. Meanwhile, congressional Republicans have expressed interest in working to make a deal on permitting reform which has long been a part of their political agenda.

### **Get Involved:**

If you want to get involved and help shape a permitting reform bill, one useful way you can advocate for the bill is by reaching out to your member of Congress (if you are not sure who that is, use this website: <https://www.house.gov/representatives/find-your-representative>). Whether you plan to call, send an email, or write a letter to your member of Congress, it is important to try to include a story about how the bill will affect you, your family, and your community. Each call, email, and letter an office receives is tallied up and considered when your Representative is deciding whether or not to support a bill, and extra weight is given to those contacts which include personal stories.

## Rail Strike Avoided

A crippling nationwide supply chain rail strike that had been set for early Friday has been avoided. On early Thursday morning, a tentative agreement was reached after around-the-clock negotiations between government officials, rail companies, and the rail unions. The tentative agreement follows the [August 16 recommendations of the Presidential Emergency Board](#), which include a 24% wage increase over five years with an immediate increase of 14.1%. Union members still must vote to ratify the agreement before it is finalized, but for now, all freight and passenger trains are expected to be running as usual on Friday.
